If your credit union account has not had any transaction activity for 365 days or more (posting of dividends is not considered activity)

the account will be assessed a \$10.00 Annual Dormant Fee, and if there has not been any activity for 3 years the California State Controller's Office requires all dormant accounts to be turned over to the State.

VISA Debit Card Update



The credit union has upgraded security on our GVFCU Debit Cards!

You may be denied at some locations, during travel and other areas outside of your local communities'. If you are traveling please contact the credit union before you go.

Debit Card fraud is on the rise everywhere and at every institution.

Criminals are always one step ahead and always try to figure out a way to hack into your information. Protect your information! DO NOT share! If you receive a call requesting your card number DO NOT give it out. The credit union will NEVER call and ask you for any of your account details

Tax Refunds

It's that time of year again when you may be receiving a tax refund. To make sure your refund will not be rejected, here are a few tips:

Individual return - is a person who files their tax returns as an individual, they will receive a tax refund payable to themselves. These can be deposited by check or direct deposit to their GVFCU account.

Joint returns-when two or more individuals file their tax returns together (usually married filing jointly) the tax refund will be issued payable to everyone on the tax form. For making that deposit all persons on the refund must be joint owners on their GVFCU account. GVFCU routing number (ABA) 321172992, you will need this number to set up a direct deposit for your tax refund along with your account number.
